

POST-GRADUATION WORK PERMIT APPLICATION (outside of Canada)

Information

- This guide is intended for graduates applying for Post-graduation work permit (PGWP) from outside Canada.
- The validity period of your work permit cannot exceed that of your passport. Therefore, you should ensure that your passport's validity exceeds the amount of time you are requesting on your application.

Eligibility:

- Completed a study program in a DLI
- The length of the study program is at least 8 months long
- The study program leads to a diploma, degree or a certificate
- Studied full time each semester except final semester
- Complied with the other conditions as a study permit holder
- You must prove your English or French language skills with a minimum level of CLB 5 in English or NCLC 5 in French in all 4 language areas:
 - Your test result must be less than 2 years old
 - Test result from these tests:
 - English: CELPIP-General, IELTS General Training, or PTE Core, or
 - French: TEF Canada: Test d'évaluation de français or TCF Canada: Test de connaissance du français

If you submit your study permit application on or after November 1, 2024

- You must also meet the **Field of study requirement**: you must graduate in an eligible field of study. Please check what Seneca programs are PGWP-eligible on this [webpage](#).

When to apply

- You have up to 180 days after you graduate to apply for a PGWP. The graduation date is the day the registrar's office issues your final marks or confirmation of program completion.

Cost

- \$255 - processing fee for post-graduation work permit application
- \$85 - some applicants may need to pay biometrics fee (check if you need to pay on this [website](#))

Required documents

- **Application for Work Permit Made Outside of Canada (IMM1295)**

- **Final Official Transcript**
To request your Official Transcript, please follow [these steps](#).
- **Completion of Studies Letter** (also known as Graduation Letter)
you can print or download your [graduation letter](#) from [Student Home](#).
- **Copy of Passport**
Scan the page with your photo and all pages with stamps and visas and permits.
- **Digital photo** ([photograph specifications](#))
- **English or French test result:**
 - English: CELPIP-General, IELTS General Training, or PTE Core, or
 - French: TEF Canada: Test d'évaluation de français or TCF Canada: Test de connaissance du français

In some cases, you may need to add the following documents:

STEP 1

- Log in/ Sign up to your [IRCC account](#)

We recommend using Option 1: GCKey
(Sign in with your GCKey user ID and password)

- Scroll down to start an application and click on '**Apply to come to Canada**', as seen below

- In the 'Determine your eligibility and apply online' section, select '**Visitor visa, study and/or work permit**'.

It is best to always reach out to an immigration specialist before you plan or require adjustment to your study progression. If you have been off-track in your study progression or have not complied to the condition of your study permit, such as having more than 1 part time status, taken multiple or long leave from studies, have been withdrawn/dropped all courses in a term, studied only from Continuing Education (part-time studies) or studied fully online only), please visit an immigration specialist to review your situation before submitting your PGWP application.

STEP 2

Answer questionnaire and check your eligibility.

- You will need to answer a series of questions before you are able to upload your required documents.
- Please find below **an example. Please keep in mind that every case is specific, and you must answer questions based on your personal case.**

STEP 3

You will be guided through the following steps to complete your application:

1. Upload your documents
 - If there is no box to upload your language test result, please upload it in the Client information box
2. Review your application
3. Pay with a credit card
4. Submit your application

After you submit your payment, you will see a page that confirms that your application has been submitted. It will have more information on next steps. Shortly after you submit, you will also receive a confirmation message in your account.

FREQUENTLY ASKED QUESTIONS

Can I work anywhere, in any type of job, under the Post-Graduation Work Permit Program?

The post-graduation work permit is an open work permit. This means that you can work in any occupation anywhere in Canada, and change employers any time you wish.

How long may it take to have your work permit application processed?

I'm waiting for my post-graduation work permit (submitted outside of Canada). Can I travel to Canada while the application is being processed?

You can travel to Canada, as long as your [visa](#) or [Electronic Travel Authorization \(eTA\)](#) is still valid. If your visa or eTA is expired, you have to wait until IRCC completes the processing of your PGWP application.
