

LEARNING AGREEMENT

Global Summer Classroom

Instructions for Students

Please read all the information below before completing and submitting the learning agreement.

This Learning Agreement is a record of what course(s) you will take in the Global Summer Classroom and outlines how the credits will be transferred to meet academic requirements.

Step 1: Check the Global Summer Classroom website to

- Review the available courses
- Ensure you meet the eligibility criteria
- Select a course that its credit will fit into your program

Step 2: Complete section A and B of this Learning Agreement.

Step 3: Connect with your Student Adviser for signature.

Please note that you must fill out all sections before sending this learning agreement to your student adviser for their review and signature.

Step 4: Submit the complete and signed learning agreement to the Global Summer Classroom Application form. *A signature from your Student Adviser is required for the Learning Agreement to be complete.*

NOTES:

Transfer credit will only be applied for courses outlined and approved in the Learning Agreement. It is the student's responsibility to ensure the Learning Agreement is completed accurately.

Instructions for Academic Program Area

This Learning Agreement acknowledges the student's intended course of Participating in the Global Summer Classroom Program.

A Student Adviser must sign this Learning Agreement. In the Student Adviser's absence, the Program Coordinator's signature is required.

What needs to be reviewed by the Student Adviser

- If the student's course selection fits within their program
- Full-time Seneca student enrolled in diploma/advanced diploma programs requiring a General Education credit
- Full-time Seneca student enrolled in a degree program requiring an upper-level LSO credit
- Course code, course name, semester the course would be taken at Seneca, and number of credits

By signing the Learning Agreement, the Academic Program Area confirms:

- The student requires the course(s)/credit(s) in Section B to graduate.
- The semester the student would take the course(s) (required by the RO for credit transfer).
- The student is in good academic standing for the Global Learning Opportunity.
