

## Tuition Fee Refund for New International Students

### ! IMPORTANT:

- In order to be eligible for a refund, this request must be received before the 10th day of classes of the semester into which the student has been admitted.
- If a decision on your study permit application has not been reached in time for you to attend, it is your responsibility to submit this form or a Request to Defer Admissions Form, if eligible.
- A copy of your passport signature page must be accompanied with this request form.
- Once your request has been granted, your refund will take approximately six weeks.
- All funds are returned to their original source of payment.

→ If your study permit application has been refused by IRCC, you must submit a copy of the visa refusal letter with this form within 14 days of the date noted on the rejection letter.

→ If you are withdrawing from the College for any other reason other than study permit refusal, an administrative fee of \$2,000 will be deducted from your semester 1 fees.

### Refund Method:

- In order to be compliant with Canada's Anti-Money Laundering policies, all refunds will be sent back to the credit card or bank account from which the funds were originally paid.
  - If a payment was made by credit card and that card is no longer active, funds will be returned to the credit card provider and the beneficiary will need to contact the provider for the funds to be released.
  - Funds paid through CIBC International Student Pay, Flywire, ICICI Bank/Unifree or Western Union Global Pay will be returned back through their portal to the account from which the funds were originally paid.
  - Payments made from within Canada using Interac or Canadian bank payments will be refunded back to the account or through e-transfer.
    - To be eligible for e-transfer, the refund must be issued directly to the student who has access to their Student Home account, Seneca email, and holds a bank account at a Canadian banking institution.
