

STUDY PERMIT EXTENSION APPLICATION (in Canada)

Online Application

Information

- Study permit extension can only be done inside of Canada.
- The validity period of your study permit cannot exceed that of your passport. Therefore, you should ensure that your passport's validity exceeds the amount of time you are requesting on your application.

When to apply

- Apply for a study permit extension at least 3-4 months before your study permit expires, if you want to keep studying in Canada

Cost

- \$150 - processing fee for a study permit extension application
- \$85 - some applicants may need to pay biometrics fee (check if you need to pay on this [website](#))

Required documents

- **Application to Change Conditions, Extend my Stay or Remain in Canada as a Student (IMM5709)**
You may read the [instruction guide](#) to understand how to complete this form.
- **Enrolment Verification letter**
To obtain an Enrolment Verification letter, you must submit an Enrolment Verification Request through Student Home (more information on this [webpage](#)).
- **Proof of Means of Financial Support**
You must prove that you can support yourself and the family members who will be with you while you are in Canada. Provide as many of these documents as you can: bank statements for the past four months, pay stubs, an employment letter, proof of assets or business, proof of payment of tuition and accommodation fees, proof of a student/education loan from a financial institution, letter from the person or institution providing you with money.
- **Proof of Provincial or Territorial Attestation Letter (PAL or TAL) OR Exception**
Upload a PAL or attach a letter of explanation to note that you meet one of the exceptions (you may check all PAL/TAL exceptions on this [webpage](#))
- **Copy of Passport**
Scan the page with your photo and all pages with stamps and visas.
- **Digital photo** ([photograph specifications](#))

In some cases, students may need to add the following documents:

- [Proof of medical exam](#)
- Photocopy of your current immigration document (such as study permit)
- Family Information Form
- Explanation Letter

STEP 1

- Log in/ Sign up to your [IRCC account](#)

We recommend using Option 1: GCKey
(Sign in with your GCKey user ID and password)

- Scroll down to start an application and click on '**Apply to come to Canada**', as seen below

- In the 'Determine your eligibility and apply online' section, select '**Visitor visa, study and/or work permit**'.

It is best to always reach out to an immigration specialist before you plan or require adjustment to your study progression. If you have been off-track in your study progression or have not complied to the condition of your study permit, such as taken multiple or long leave from studies, please visit an immigration specialist to review your situation before submitting your study permit extension application.

STEP 2

Answer questionnaire and check your eligibility.

- You will need to answer a series of questions before you are able to upload your required documents.
- Please find below an example. Please keep in mind that every case is specific, and you must answer questions based on your personal case.

What would you like to do in Canada?

A medical exam is needed before you submit your application for foreign nationals who:

- want to stay in Canada for more than 6 months and have lived in one or more designated countries or territories for more than six months in the past year or;
- intend to work in one of the following jobs:
 - health sciences worker
 - clinical laboratory worker
 - patient attendant in nursing or geriatric homes
 - medical student admitted to Canada to attend university
 - medical elective and physician on short term assignment
 - teacher of primary or secondary schools or other teachers of small children
 - domestics worker, someone who gives in-home care to children, the elderly and the disabled
 - day nursery worker

STEP 3

You will be guided through the following steps to complete your application:

1. Upload your documents
2. Review your application
3. Pay with a credit card
4. Submit your application

After you submit your payment, you will see a page that confirms that your application has been submitted. It will have more information on next steps. Shortly after you submit, you will also receive a confirmation message in your account.

FREQUENTLY ASKED QUESTIONS

I've applied to extend my study permit. Can I travel outside Canada and be able to return?

Yes. You can leave Canada and return as long as your visitor visa or Electronic Travel Authorization (eTA) is still valid. If your visitor visa or eTA is expired, you must apply for and receive a new one before you leave.

Exception

There's only one exception to this. You may be able to re-enter Canada with an expired visitor visa (not an expired eTA) if:

- you only visit the United States or St. Pierre and Miquelon and
- you return to Canada before your study permit expires.

When you return to Canada

If your study permit is still valid, or IRCC extended your permit while you were away, IRCC may let you enter as a student.

If IRCC is still processing your study permit extension, IRCC may let you enter as a visitor. In this case, you can't study until you get your extended study permit. The officer at the port of entry may also ask you to prove you have enough money to support yourself in Canada.

A border officer may have some questions for you when you arrive back in Canada. If the officer believes there's reason to refuse your re-entry, you won't be able to re-enter Canada. The officer may ask you for a copy of your extension application, the fee payment receipt, or any other document to prove you applied for an extension.

Can I stay in Canada after my study permit expires if I applied for a new permit?

Yes. You can stay in Canada as a temporary resident until IRCC makes a decision on your new permit application. You must make sure you applied for a new permit before your original permit expired.

If you applied to extend your study permit, you can stay in Canada and continue studying under the conditions of your original study permit if you

- applied to extend your study permit before your original permit expired
- are waiting for a decision on your study permit application
