## About Campus Meal Plans

The meal plan you load to your OneCard works like a debit card: whenever you buy a meal on campus, the amount of your purchase is subtracted from your account.

All meal plans can be used at any Seneca Dining Service location at Newnham, King and Seneca@York Campus, including the Residence at Newnham Campus.

## Meal Plans

### Seneca Soup Program

The Seneca Soup Program helps to ensure all students enrolled in either a full- or part-time program have access to a healthy meal on campus — free soup made fresh daily. Halal, vegetarian, vegan and gluten-free options will be offered. Students are required to sign up for the program but there is no cost to participate.

### Casual Plan

The Casual Plan offers more than \$200 in savings over a two-month period. Enjoy tax free savings and receive \$50 **FREE** bonus dollars towards all meal purchases. This means you pay \$550 but you get an approximate spending value of \$600.

### Light Eater Plan

The Light Eater Plan offers more than \$300 in savings over a two-semester period. Enjoy tax-free savings and receive \$100 **FREE** bonus dollars towards all meal purchases. This means you pay \$1,495 but you get an approximate spending value of \$1,595.

## Semester Plan

The Semester Plan offers more than \$200 in savings over a one-semester period. Enjoy tax-free savings and receive \$80 **FREE** bonus dollars towards all meal purchases. This means you pay \$995 but you get an approximate spending value of \$1,075.

## Ultimate Plan

The Ultimate Plan offers more than \$400 in savings over a two-semester period. Enjoy tax-free savings and receive \$200 **FREE** bonus dollars towards all meal purchases. This means you pay \$1,990 but you get an approximate spending value of \$2,190.

## Tax exemption

Meal Plans are tax exempt when used for a meal at Seneca Dining locations within the duration of their tax-free status. The tax-free status will expire once the tax exempt duration is over. The tax-free status for each plan is as follows:

- Casual Plan: Two months
- Light Eater Plan: Two semesters
- Semester Plan: One semester
- Ultimate Plan: Two semesters

## Seneca Dining locations include

Markham Campus: Main Cafeteria

King Campus: Main Cafeteria, Starbucks Magna Hall

Seneca@York Campus: Main Cafeteria, Tim Hortons

Newnham Campus: The Market, International, The Grill, Salad +, Pizza + Pasta, Tim Hortons, Café, Starbucks, Starbucks CITE

## Locations where meal plan can be used, but tax-free status does not apply

Seneca@York Campus: Hot dog stand

Newnham Campus: Subway, residence Convenience Store and hot dog stand

## Bonus Dollars

Bonus Dollars are an incentive for students who purchase Meal Plans. Bonus Dollars expire if they are not used within the specified duration of the Meal Plans and they are not transferable.

Bonus dollars are only used after the meal plan purchase amount has been spent.

## Employee Meal Plans

### Your Way Plan

The Your Way Plan offers \$100 in **FREE** bonus dollars towards all meal purchases. This means you pay \$500 but you get an approximate spending value of \$600. This plan does not expire.

### Taking it Easy Plan

The Taking it Easy Plan offers \$25 in **FREE** bonus dollars towards all meal purchases. This means you pay \$250 but you get an approximate spending value of \$275. This plan does not expire.

### TGIF Plan

The TGIF Plan offers \$5 in **FREE** bonus dollars towards all meal purchases. This means you pay \$100 but you get an approximate spending value of \$105. This plan does not expire.
